### FRAMEWORK COLLABORATION AGREEMENT BETWEEN IRAN PISTACHIO ASSOCIATION AND THE EUROPEAN PISTACHIO COUNCIL

In Toledo (Spain), on July 3rd, 2023.

### MEETING

- On the one hand, the European Pistachio Council Association (Consejo Europeo del Pistacho), registered in Group 1, Section 1, National Number 620888 of the National Register of Associations of Spain, and with address at Cale Columela, 9 –4 decha, 2001, Madrid, for these purposes, and represented by its President, Carlos Suárez Morales, with ID card number 624749866 (Spain).
- On the other hand, the Iran Pistachio Association, a non-profit private organization, registered in Iran with National ID Number 10320841849, and with a physical address of No. 12, 2nd Lari Najaf Street, Jomhoori Eslami Blvd., Kerman, IRAN, for these purposes, and represented by its President, Mohammad Salehi with ID card number 3070297404 (Iran).

Both parties mutually and reciprocally recognize that they have sufficient capacity and legitimacy to enter this collaboration agreement.

### EXHIBIT

- That the European Pistachio Council main purpose is to be a tool for the defense, representation, and promotion of the Spanish and European pistachio.
- That the main objective of the fran Pistachio Association, above and beyond establishing itself as a representative and think-tank of the Iranian pistachio industry, is to diagnose diverse problems and complications that afflict the industry and offer expert advice and guidance to members to further their interests.

That both associations value very positively to maintain close contact in order to identify opportunities of collaboration that are of mutual interest, for which they subscribe the present agreement which contains the following.

### STIPULATIONS

### FIRST: Purpose of the Agreement

The European Pistachio Council and the Iran Pistachio Association agree to establish a framework of institutional relationship within which various collaborations related to the pistachio sector and the developed.

### SECOND: Content of the Agreement.

The present agreement is subscribed for the joint realization by the European Pistachio Council and the Iran Pistachio Association of the following items:

- A- To collaborate in the communication between members of both associations in order to be a link between them.
- B- To be the vehicle and impulse for the organization of visits to Europe and/or Iran that are of interest for the associates of both institutions.
- C- To be the vehicle and impulse for the organization of conferences (face-to-face or virtual) that are of mutual interest for the associates of both institutions.
- D- Work together to identify collaborative projects and activities related to pistachios.

### THIRD: Rules of Operation

The collaborations derived from this Framework Agreement shall be subject to the provisions of the Statutes of the European Pistachio Council and the Iran Pistachio Association, and to the content of the corresponding Specific Agreements, considering the nature of the work and activities to be carried out.

### FOURTH: Monitoring of the Agreement.

For the purpose of evaluating the proper fulfillment of this framework collaboration agreement, a Monitoring Committee will be created, made up of two persons, one appointed by the European Pistachio Council and the other by the Iran Pistachio Association.

For the European Pistachio Council: Mr. Carlos Suárez Morales

For the Iran Pistachio Association: Mehrdad Agah

### FIFTH: Effective Date and Duration.

This Framework Agreement shall enter into force at the time of its signature and shall remain in force as long as the parties do not decide otherwise.

### SIXTH: Modification Termination and Rescission

The parties may amend this Agreement at any time by mutual written agreement.

Either party may, in turn, terminate the agreement by giving written notice to the other party one month prior to the date on which it is to be terminated.

And in witness whereof, have signed this Framework Agreement in duplicate at the place and on the date indicated above.
